Dear Ms. Matthews:

The Clay County Board of County Commissioners on May 25, 2021 considered the purchase by Clay County from Election Systems and Software, LLC ("ES&S") certain voting equipment described in the proposal, attached hereto as **Exhibit A**, as a single source purchase.

The existing voting tabulation system utilized by the County's Supervisor of Elections is provided by ES&S, which is one of only two vendors with certified voting systems in the State of Florida. The ES&S voting tabulation system is comprised of hardware and software components manufactured exclusively by ES&S for certification as a State of Florida election tabulation system. To allow for the continued use of the ES&S DS200 precinct tabulation system, Ballot on Demand printers, electionware, and the election management software, upgrades are needed to the existing equipment and software manufactured exclusively by ES&S. Additionally, to meet the needs of the current and future growth of voters in the County, the County wishes to purchase additional DS200 Precinct Scanners and DS 200 Wireless Modems for the Supervisor of Elections. The purchase of this equipment via a single source is the most economical solution as it will allow the County to avoid having to purchase a new voter tabulation system from a separate vendor at an increased cost.

In accordance with Section 101.293(1)(b), Florida Statutes, the Clay County Board of County Commissioners, by a majority vote, has determined ES&S to be the single source from which the necessary voting equipment may be obtained, justifying an exception to the competitive sealed bidding and competitive sealed proposal requirements of Section 101.293, Florida Statutes and Rule 1S-2.004, Florida Administrative Code.

The notification and information provided herein is provided in compliance with the requirements of Sections 101.293(1) and 101.294(2), Florida Statutes, and Rule 1S-2.004, Florida Administrative Code, as to the purchase and sale of voting equipment, and shall constitute the certification required under Section 101.293(1), Florida Statutes.
